Key Dates & Deadlines

1st June 2025

Pharmacy First

- New caps in effect — Check NHSBSA website.
- Fixed payments: £500 for 20–29 consultations; £1,000 for 30+.
- One-month claim window starts — Claims for March–May must be submitted by 30th June.
- Must be registered to deliver HCFS, PCS, and Pharmacy First - [achieve the fixed payment](#)

12th June 2025

DMS

- New streamlined claims process starts 6th July 2025.

30th June 2025 – Final Deadline Day

- Complete DSP Toolkit submission - [Data Security and Protection Toolkit](#).
- Update NHS Website/DoS Profile. – [NHS website](#)
- Submit all DMS activity before deadline.
- Final day to claim Pharmacy First for March–May.

1st July 2025

- Use new DMS system from 6th July.
- PQS aspiration payments issued.

6th July 2025

- New DMS claims process begins - [DMS claim journey](#)

Pharmacy First: Monthly Payment Update

- £500 for 20–29 consultations/month.
- £1,000 for 30+ consultations/month.
- Must claim within one month of service delivery.
- Bundling requirements phase-in from June 2025 to March 2026.

Pharmacy Contraception Service (PCS) Updates

- Consultation fee raised to £25 from April 2025.
- Technician provision pending NHS updates.
- Drospirenone & EHC additions planned – wait for further updates.
- National service may replace local EHC services.

Core Opening Hours – New Application Route

- Simplified from 23rd June – based on regular patient needs.
- ICBs must consider pharmacy business needs.

PHARMACY SHIFT Study: Welcome to the **PHARMACY SHIFT** Study by Imperial College London Self-Care Academic Research Unit (SCARU).
